2014-2022	HBSD 4110 Behavior Change Strategies for Diabetes Management	Master's (online,
	Course Description: This course explores different approaches to working with people who have diabetes and ways health care professionals can help them successfully manage and live well with diabetes. Students also explore the role of generations in behavior change. Particular focus is placed on language and how messages/words can influence patient-provider relationships and possibly health outcomes.	asynchronous)
2011-2021	HBSD 4120 Pathophysiology of Diabetes and its Related Complications	Master's (online, asynchronous)
	Course Description: This course covers the physiology of normal energy metabolism and the pathophysiology of energy metabolism as seen in metabolic syndrome/pre-diabetes, the progression to type 2 diabetes, overt type 2 diabetes, as well as type 1 diabetes, gestational diabetes, and drug-induced diabetes. The risk factors for type 2 diabetes are discussed. The metabolic crises precipitated by hyperglycemia are described along	,

with their symptoms and diagnostic features. Comorbid conditions and

disorders commonly associated with diabetes (e.g., hypertension, dyslipidemia, depression) are reviewed. The acute and chronic complications related to diabetes are discussed. The pathophysiologic pathways, signs, and symptoms of diabetes-related complications including microvascular and macrovascular disease are also addressed.

2012-2022 HBSD 4130 Assessment of the Person with Diabetes

Course Description: This course takes a deep look at assessment from new and different perspectives. Starting with the diabetes professional, we assess implicit biases and discuss the DAWN (Diabetes Attitudes Wishes and Needs) Studies, which identified a severe lack of addressing the emotional side of diabetes. We then discuss assessment of the whole person: health beliefs; education/knowledge/learning styles; health literacy; diabetes distress; culture; psychosocial as it relates to diabetes (including drug use, social determinants of health, family support, anxiety, fears, and patient-reported outcomes {PROs}); and focused clinical assessment. The importance of defining measurable, realistic and attainable goals – both clinical and behavioral – and the research behind goal setting are discussed. Nutrition and physical activity assessment are also discussed, along with special considerations for children, adolescents, and the elderly. The role of the diabetes care and education specialist in creating a trusting environment to enhance open communication with patients/clients is emphasized throughout.

2012-2022 HBSD 4140 Preventive & Therapeutic Interventions in Diabetes Management

Course Description: This course covers therapies used to prevent, treat, and manage diabetes across the lifespan. Prevention of chronic comorbidities and acute complications will be studied and discussed in accordance with evidence-informed clinical practice guidelines. Exploration of the primary components of diabetes therapeutic management will include the following:

2011-2023 HBSD 4150 Diabetes Self-Management Education and Support Programs: Development, Implementation, and Evaluation

Course Description: HBSD 4150 provides guidance for implementing the National Standards for Diabetes Self-Management Education and Support to create DSMES programs that will fulfill ADA recognition or ADCES accreditation requirements. The course covers the following areas addressed by the Standards:

- Organizational structure, mission statement, and goals
- Advisory group

HBSD 4160 Pharmacology of Diabetes

Course Description: This course offers an in-depth exploration of the medications used to treat and reduce the risk for diabetes, as well as the drugs used to treat its related comorbidities and complications. Drug classes, names, mechanisms of action, pharmacokinetics, and pharmacodynamics will be discussed, as well as drugs currently being investigated. This course includes a discussion of the FDA approval process, drug studies, considerations for special populations, precautions, and adverse effects.

Master's (online, asynchronous)

2016-2022 HBSN 6

HBSN 6000 Nursing Theory in Nursing Education

Course Description: This course introduces the history of nursing knowledge and how this foundation has shaped and continues to shape nursing education, practice, and research. Students learn about and discuss ways of knowing in nursing and the impact of major theoretical perspectives on nursing education/practice/research. Students also consider how this body of knowledge can be used to guide policies and practices in nursing education to promote student learning and development, nursing research, and ultimately nursing practice. This course offers students an opportunity to critically appraise and develop educational approaches to effectively teach nursing knowledge. Finally, in this course, students will think about nursing theories that could be used to guide their dissertation research.

Doctoral (online, asynchronous)

2022 HBSN 5044 Advanced Research Methods

Course Description: This course builds on the introductory research methods course to enhance students' abilities to design research, interpret research findings, critique research reports, and write the review of literature for their dissertation proposals. Issues affecting the design of research and interpretation of research findings in Nursing Education studies are also a focus of the course.

Doctoral (online, asynchronous)

2023, 2024 HBSN 6540 Dissertation Design & Development

Doctoral (online, asynchronous)

Course Description: This course serves to guide advanced doctoral students in producing a written dissertation proposal. Students in the course will also orally present their proposals and critique the proposals of fellow students in the course. In addition, various aspects of the research process will be discussed. Throughout the course, students will be in touch with their dissertation advisors and at specific points in the course, advisors will be asked for their feedback.

2024, 2026 HBSN 4199 Critical Issues in Diabetes for Health Care Professionals

Course Description: Diabetes is the number one comorbidity in the US. Every health care professional in every discipline will see people with diabetes and therefore needs a knowledge base in the critical issues facing this population. This course provides content that will prepare current and future health care professionals to work effectively with people living with diabetes, including communication, health behavior change, monitoring, medications, technology, advocacy, research, and AI.

2025, 2026 HBSN 4199 Introduction to Qualitative Methods for Health Care Professionals
